**HCFMA Requirements and Criteria for Not-for-Profit Organizations**

**Approval of this application depends on whether the organization meets these criteria:**

1. The activity must benefit the local community.
2. The activity must be compatible with and enrich the activities of the Farmers' Market.
3. The activity should not simply entail handing out pamphlets and /or collecting money.
4. It is understood that the NFP organization will provide its own table and canopy.
5. All vendors, including NFP organizations are expected to keep their tables open for the entire market session and not to begin to tear down until the market has closed.
